During the year to date, as at 1 July 2021, the Force has recruited 32 officers, 30 of which are new student officers and 2 who have transferred into the Force from other Forces. For the student officers 40% of those starting are female and 20% are from Black, Asian and Minority Ethnic backgrounds.</p> <p>In terms of attrition, as at 1 July 2021 the Force has lost 21 FTEs, of which 9 have been student officers. 11 of the leavers are female and 2 are visible Black, Asian and Minority Ethnic.</p>
