DEPUTY PCC CUSTODY VISIT


Bedfordshire's Deputy Police and Crime Commissioner has visited the force's custody facilities in the latest check on detainees' welfare in the county.

The Office of the Police and Crime Commissioner (OPCC) runs the independent custody visitor programme, where volunteers attend police stations to check on the treatment of detainees and the conditions in which they are held.

It follows a previous out of hours visit by PCC Festus Akinbusoye last month.
