Bedfordshire PCC reacts to police pay award

Police officer pay will increase by seven per cent across all ranks from September 1 after the Government accepted in full the recommendation of the Police Remuneration Review Body (PRRB).

Bedfordshire Police and Crime Commissioner Festus Akinbusoye said: "I'm delighted the Prime Minister has accepted in full the recommendations of the Public Sector Pay Review Body, recognising the fantastic work our police officers do every day.

"While this is good news for our officers, I'm keen police staff who play a crucial role supporting colleagues both on the front line and behind the scenes, are similarly also recognised for their efforts.

"We are still awaiting the detail of the pay award, but it is reassuring that the Home Office has indicated additional funding will be provided to support the cost of that increase, which is particularly important for Bedfordshire at a time when our officer numbers are at a record high thanks to the recent Uplift programme to bring in 20,000 additional officers nationally.


Safer Streets Household Booklet

Spotlight on the **Stop and Search and Use of Force Scrutiny Panel**

What is the Stop and Search and Use of Force Scrutiny Panel?

Stop and Search and Use of Force are essential tools in preventing and reducing crime and when used appropriately, this can be effective in keeping the communities of Bedfordshire safe. Nonetheless, it is important that the public understand their rights when they are stopped and searched or when force is used by officers carrying out this pivotal role. The Police and Crime Commissioner holds Bedfordshire Police to account for their delivery of Stop and Search and the Use of Force.

The Office of the Police and Crime Commissioner holds the governance responsibility for the Stop and Search and Use of Force Scrutiny Panel meeting and attends the meeting as an observer.

The Stop and Search and Use of Force Scrutiny Panel is made up of local residents in Bedfordshire. They review Stop and Search and Use of Force data and outcomes.

What do the volunteers do?

The group of volunteers scrutinise how Bedfordshire Police use force and other coercive powers with the aim of improving the trust and confidence Bedfordshire communities have in the police through transparency and independence.

Scrutiny panel members review body-worn video footage of incidents where officers have used force or carried out a stop and search.

The police's conduct is then reviewed and graded using a traffic light system and fed back to the force to respond to accordingly.

Earlier this year, the force was praised by His Majesty's Inspectorate of Constabularies and Fire & Rescue Services (HMICFRS) for the work it does to ensure the ethical use of stop and search and use of force powers.

Round up of some of the Commissioner's activities



Spoke with nearly a hundred young people in Luton during summer camp activities, focusing on their use of social media.



Met with Chief Constable Trevor Rodenhurst. He was provided with updates on stabbing investigations, performance of force control room, Bedfordshire's Sexual Assault and Referral Centre (SARC) inspection by Care Quality Commission, Community Policing, police misconduct hearings and overall risk planning.



Visited Cranfield University to see the exceptional knowledge centres housed there. He met with leads from Cranfield Forensics Institute where postgraduate training is delivered in partnership with forensics experts from policing and investigations to students.



Invited to take part in a podcast with commissioned partner, Mary Seacole Housing Association, to discuss their work on community mediation, public confidence in policing and the issue of hate crime.



Visited the ground-breaking aviation research centres to learn more on why Artificial Intelligence combines with Human Behaviour Science for improving air travel. The Commissioner went on to meet Cranfield Aerospace Solutions to see their investment into hydrogen powered air travel.
