Bedfordshire PCC consults with residents about police precept for 2024/25

The Police and Crime Commissioner (PCC) for Bedfordshire, Festus Akinbusoye, has released the [police precept survey](#) for the financial year 2024/25. The PCC must consult with local residents on any changes that he is considering to the police precept. For 2024/25, the PCC wants to propose an increase to the police precept of £13 a year for an average Band D property.

In 2024/25 the focus will be on:

- Retail crime
- Force control room
- Crime prevention
- Improved outcomes for victims through immediate justice
- Speeding

The [police precept survey](#) will close at 5pm on 12 January 2024 and will form part of the report to the Police and Crime Panel that will meet to consider recommendations from the PCC on 6 February 2024.

New centre launches to reform perpetrators of domestic abuse



Inspiring change, transforming lives, delivering safer communities

A major new programme to help reform perpetrators of domestic abuse and encourage them to change their behaviour is launching in Bedfordshire.

Chrysalis Centre is a ground-breaking programme of interventions to break the cycle of domestic abuse making victims, families and communities safer. This is achieved by challenging underlying abusive behaviours and providing education and support to enable healthy, safe and positive relationships.

Central to the role of Chrysalis Centre is the effective screening of referrals to understand causation factors, including Adverse Childhood Experiences, substance or alcohol dependencies.

The Chrysalis Centre has been developed to work directly with individuals and encourage them to access a range of available behavioural change interventions, as well as support for compounding issues such as substance abuse or poor mental health.

Bedfordshire Police and Crime Commissioner Festus Akinbusoye has partnered with his counterpart in Hertfordshire to successfully bid for £2 million from the Home Office to run the programme for the next two years.

The Chrysalis Centre ensures that a trauma informed, person centric approach is at the heart of its work.

The announcement comes in the midst of 16 days of action against gender based violence, which aims to raise awareness of domestic abuse and violence against women and girls.

PCC hosts 2-day event to combat rural crime in Bedfordshire

The PCC and Deputy PCC Ian Dalgarno joined forces with Bedfordshire Police's Rural Crime team and National Farmers Union (NFU) county chairman Freya Morgan.

The events, in the north and south of the county saw different groups pledge to continue to work together to tackle rural crimes that impact rural communities.

Deputy Commissioner Ian Dalgarno said: "It was an invaluable opportunity to meet with our farming communities and hear from them directly at our annual event.

"Last December we launched a 'rural task force' vision, so we were able to come together as a group and check in on any issues or concerns.

"I'm confident that we're working in collaboration to ensure crimes are being reported and investigated and indeed updated fed back to our rural communities.

"It is vitally important that the police ensure our rural communities feel as safe and protected as those who live in our larger towns.

"The energy and enthusiasm from the meeting alongside some recent action we have taken gave confidence to our farming community that we continue to be on the same page to crackdown on rural crime."

Mr Akinbusoye said "This event gives us the opportunity to tap into the farming community's network and local knowledge, as well as key information sharing between Beds Police and the farming communities.

"These meetings are crucial for improving performance and delivery of police service in our rural areas and we now have action plans in place for next year."

Bids will be reviewed by an evaluation panel provisionally arranged for 24th January and 25th January 2024.

Where relevant, a period of evaluation clarification will take place between 29th January and 2nd February 2024.

All bidders will be notified of outcomes on the 16th February 2024.
