

Declaration of interests

To safeguard the integrity of the Police and Crime Commissioner (PCC), it is essential that any declarations of interest are publicly made to ensure openness and transparency and to safeguard the PCC against any potential challenge.

All declarations should be declared and reviewed annually as a matter of course. The PCC can update the declarations at any time should his or her circumstances change.

The declarations will be held on a register in the Office of the Police and Crime Commissioner (OPCC) and will be made available through the OPCC website.
